### Fire Chief's Report

Joel Meeter presented chiefs report for Chief Herrington.

- 10 calls since last meeting (5 MVA, 3 medicals, 1 carbon monoxide investigation)
- 5 members attended EMSAC earlier in the month.

- Kendra will be attending Aims Community Colleges “Women in Fire”. This is a free training which is female oriented.
- Patrick is attending fire academy in Colorado Springs.
- Extrication training in early November but many people were at EMSAC or out of district. May try to repeat.
- December training will feature PVREA and issues with electricity and solar panels.
- No new members. Most everyone is meeting training and call minimums.
- We received an insurance reimbursement for Engine 131 after an engine fire. Rocky Mountain Truck and Trailer fixed electrical problems and the alternator.
- The completion of the Incident Support Trailer is delayed due to supply issues.
- The new defibrillator is coming this week. It will be kept on Rescue 1. Total costs were \$47,000 with \$20,000 reimbursed by a grant. The old defibrillator will move to Med 1.
- The extrication tools need to be serviced soon.
- A homeowner of a newly constructed home invited Chief and others to view his new cistern/sprinkler system as well as his security system.
- Dave Herder gave an extensive update on the status of Station 4. Ready to send out RFPs.

A motion for LFPD Board to authorize Chief Herrington to solicit RFPs for the purpose of building Fire Station 4 was made by Cindy Cosmas and seconded by Chad Uthmann. Motion approved unanimously.

Chief Herrington shall send draft RFP to the board for comments prior to sending it out for solicitation.
